Personal data that we process

IntSAAB2020 processes your personal data because you use our services and / or because you provide us with information. Below you will find an overview of the personal data we process:

- First and family name
- Address
- Telephone number
- Email address
- Other personal data that you actively provide, for example, data about your Saab, written or oral.
- Location data.
- Bank account information.

Special and / or sensitive personal information that we process.

Our website and / or service does not process sensitive personal data and do not intend to disclose information about participants under 18 years unless they have permission from parents or guardians. We are not able to check if participants are under 18 years. We recommend parents to be involved in their children's online activities to prevent that information about children is collected without parental consent. For what purpose and on what basis we process personal data.

IntSAAB2020 will process your personal data for:

- Handling of your registration
- Handling of your payment
- Distribution of our newsletter and / or advertising leaflets
- Being able to call or email you if this is necessary to be able to perform our services
- Inform you of changes to our services and goods
- To deliver goods and services to you.

Automated decision making

IntSAAB2020 does not process data based on automatic processing of data that may have consequences for humans.

For how long are the personal data retained.

IntSAAB2020 does not retain your personal data for longer than is strictly necessary to fulfill the purpose for which we collected the data.

Sharing of personal data with third parties.

We will sign a processing agreement with third parties that process your data on our behalf to ensure the same level of security and confidentiality of your data.

IntSAAB2020 remains responsible for these processes.

Cookies or similar that we use

IntSAAB2020 uses only technical, functional and analytical cookies that do not violate your privacy. A cookie is a small text file stored on your computer, tablet or smartphone when you first visit these sites.

The cookies we use are necessary for the technical operation of the website and for user-friendliness. They ensure that the site is functioning properly. We can also optimize our website with this.

You can deselect cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete any information previously stored through the settings in your browser.

View, edit or delete your data

You have the right to view, correct or delete your personal data. Additionally, you have the right to withdraw your consent to data processing or to object to the processing of your personal data by IntSAAB2020, and you are entitled to data transfer. This means that you can submit a request to us to send the personal data we hold about you in a computer file to you or another organization of your choice. You may submit a request for access, correction, deletion, data transfer of your personal data or request for withdrawal of your consent or objection to the processing of your personal data to info@intsaab2020.com. To ensure that the request has been made by you, please enclose a copy of the photo page of your passport with your request. This is to protect your privacy. We will respond to your request as quickly as possible, but within two weeks.
